Includes doors on the short sides to facilitate access of stretchers or medical equipment. Includes wide doors in the long sides of the cage. The inside of the basket is empty to maximize the available space.

Transport Cage BA-185B

Includes doors for stevedores. The inside of the basket is empty to maximize the available space.

- · Rubber bumper along the whole external perimeter of the cage.
- Safety net to prevent from falling objects inside the cage.
- · Documentation and signs / plates in any language upon customer's request.

- · No need for internal or external energy supply.
- · No need for extensions or modifications on the spreader.
- · Significantly increased occupational safety: the lashers work in an area which is protected all around, also against falling objects.
